Roadside Inspection Violations Not Correct? Document, Document, Document

If you receive a roadside inspection with violations you don't feel are right there are things you can do to help us challenge the violations. Follow the below steps:

- (1) Send us your inspection report ASAP (company policy no later than 48 hours from time of issuance)
- (2) Take pictures of any items you feel are incorrect. Date/Time stamp documentation is critical in challenging invalid violations and lessens the He Said/She Said scenario.
- (3) DO NOT get argumentative with the inspecting officer. Things could go south quickly!
- (4) Send all other repair documentation with your report.
